- 1. Must be eighteen (18) Years of age. (copy of Drivers License or Birth Certificate)**
- 2. Shall be a high school graduate or have successfully passed a GED and provide written proof (copy of high school diploma or transcripts or GED certificate)**
- 3. Must have completed one year of high school math course(s) with a grade of C or better, or submit equivalent math placement test scores.**
- 4. Documentation of the requirements listed above must be submitted with application**

**Industrial Maintenance Millwright 4 year program**

A millwright is a skilled craftsperson who installs, repairs and reassembles machinery in factories and on construction sites. Millwrights rely on precision in their work, following multistep instructions to perform their job correctly. They follow regulations concerning quality and safety. They will also install, troubleshoot and maintain:

- 1) General Maintenance
- 2) Maintenance and repair of machinery Dismantle, rebuild, repair, assemble and install plant machinery including but not limited to engines and transmission, hydraulic, pneumatic, piping, control and transportation systems
- 3) Lubrication Oils and greases
- 4) Welding Arc and acetylene
- 5) Basic machine shop practices

Additional Work hours are also required according to the individual employers needs

The Average Journeymen's wage thru June 2026 is \$41.26. An apprentice starts at 80% (\$33.00) of that with 2%-3%-pay increases every 1000 on the job hours and 72 school hours.
