- 3. Must have completed one year of high school math course(s) with a grade of C or better, or submit equivalent math placement test scores.**
- 4. Documentation of the requirements listed above must be submitted with application**

**Limited Maintenance Electrician 2 year program**

Repair and maintain existing electrical installations on or in an existing operable plant, commercial building, or institution. An LME is not authorized to make new electrical installations or to perform work on services. They will also install, troubleshoot and maintain:

- 1) Motors and Generators
- 2) Manual and automatic controls, including magnetic and solid state
- 3) Trouble Shooting
- 4) Lighting
- 5) Electrical oriented drawings
- 6) Power Distribution

Additional Work hours are also required according to the individual employers needs

The Average Journeymen’s wage thru June 2025 is \$40.20. An apprentice starts at 80% (\$32.16) of that with 5%-pay increases every 1000 on the job hours and 72 school hours.
